	<p>Future Contact with Parishioners (TM): EM stated that though he would have liked to issue this before the Autumn half-term he wishes it to “stand-alone” and not be linked with the Diocesan financial review scheduled for the Autumn. To this end he does not wish to place it in the public domain until clarification of the Diocese’s actions is received.</p> <p>It was noted the social activity of the parish is improving the community life of the parish and this in turn may lead to a better network to encourage parishioners into the different parish groups – all of which would welcome new members.</p> <p>TW asked about CRB checks and EM confirmed TG was very rigorous in his attention to these checks within the parish. He also confirmed to CG that it is necessary to have CRB checks completed for every different area with which an individual was involved.</p>
